E D I T O R I A L

This issue of the Newsletter fulfils a longstanding intention of the Business Archives Council (Scotland). It is the first occasion on which two issues of the Newsletter have been published in one year and it is hoped to continue this in the future. This extension makes it possible to keep our readers more closely in touch with the work going on in the location, preservation and listing of business archives in Scotland.

Publication twice yearly has also made it possible to vary the content of the winter and summer issues. The winter issue will be devoted mainly to a summary of the work of the preceding calendar year, while the summer number will primarily publish more detailed abstracts of surveys noted in earlier issues. There is a large backlog of such information. A start has been made with the lists of the Western Survey, and those which appear in this issue were previously noted in Newsletter No. 6. The summer publication will also include the latest addition to the bibliography of recent work on Scottish business and economic history. This is kindly supplied by Professor P.L. Payne of Aberdeen. In this way the Council and its members keep abreast with the surveys, listing, research and publications in Scottish business history.

It has always been the policy of this Council to stimulate the interest of the business and general community in the preservation and use of business records. Over the years there has been a fruitful and congenial co-operation among academics, businessmen and other interested parties. In the past two years this has been particularly evident in the effort to save the records of Upper Clyde Shipbuilders. This issue of the Newsletter reprints the press release of 13 September 1973 which publicly marks the success of this operation. The Council is indebted to many persons and bodies for their work and help with this collection. Particularly so to Mr. R.C. Smith in his capacity as liquidator and as chairman of the Business Archives Council (Scotland), to Mr. John Imrie, Keeper of the Records of Scotland, the Corporation of Glasgow, Dumbarton County Council, and Clydebank Town Council, in bringing the negotiations to a successful conclusion. The Universities of Glasgow and Strathclyde and the Glasgow City Archives have also contributed to this end in a substantial way.

It will be plain from the following article that the records of Upper Clyde Shipbuilders are unusually important. The staff of the Scottish Record Office will embark on the mammoth task of re-listing them in the autumn: the first fruits of their labours should be available for publication early in the new year.

It is our intention to bring our readers more information on the richness and extent of the collection in later issues of the Newsletter. Although this is only one of the many hundreds of collections which have been saved in the past thirteen years, it is one of outstanding importance and represents an achievement in which the Council can justly claim no small credit.

SHIPBUILDING RECORDS SAVED FOR SCOTLAND: PRESS RELEASE ON 13 SEPTEMBER 1973
GOVERNMENT-LOCAL AUTHORITY CO-OPERATION ACQUIRES UNIQUE COLLECTION

A collection of records dating back to 1847 has been saved for Scotland. The collection comprises the records of John Brown's, Fairfield's, Alexander Stephen and Sons and Simons-Lobnitz, together with the records of the predecessors as shipbuilders on the Clyde. A note on the companies concerned is attached.

The records, which belonged to constituent companies of Upper Clyde Shipbuilders, have been purchased from the liquidator with the help of a Treasury grant and of contributions (together totalling half the purchase price) from Glasgow Corporation, Dumbarton County Council and Clydebank Town Council. They have been acquired at a cost of £18,000 and will pass into the custody of the Keeper of the Records of Scotland.

This marks the successful outcome of negotiations which were initiated some time ago with the authority of the Secretary of State for Scotland, who was concerned that this unique collection should be kept intact in Scotland. The Secretary of State has welcomed the readiness with which the three local authorities in the West of Scotland agreed to contribute to the cost of acquiring it. This is the first joint venture of this kind between Government and local authorities in joining together to save historic documents in Scotland.

The cost was shared among the interested parties as follows:-

While the collection has been purchased on behalf of the Keeper of the Records, it is expected that when suitable facilities for archives are developed in the West of Scotland, following local government reorganisation, the collection will be permanently housed there under the Keeper's charge and superintendence. Pending the provision of such facilities temporary storage has been provided by the University of Glasgow and the Glasgow City Archives. The collection of cinematograph film is temporarily housed with the Scottish Film Council.

The records constitute the largest and most comprehensive collection of their type in the United Kingdom. They cover all stages of ship construction and shipbuilding techniques during a period which will continue to be of great interest to many in Scotland and elsewhere.

The work of listing the records is already well advanced, thanks to the co-operative efforts of the staffs of the National Register of Archives (Scotland); its Western Committee; the Glasgow City Archives; and the Universities of Glasgow and Strathclyde. Pending checking and referencing by Scottish Record Office staff some limitations will have to be imposed upon public access. Among items included in the collection are plans of ships dating from 1869. The Clyde yards had a high tradition of draughtsmanship and many of these plans are works of art in their own right. They cover vessels from ocean liners (Queen Mary, Lusitania, etc.) to steam yachts and Clyde steamers, and warships of all types from the pre-Dreadnought era to the Vanguard (including Good Hope, Barham, Hood and many other famous names). There are also many plans of unusual and specialised craft: paddle steamers, monitors, dredgers and even a special missionary boat designed for use on African rivers.

The collection includes engine drawings from the 1850's, such as those for the first successful marine triple expansion engine, and photographs and photographic negatives from about 1880 covering all stages of ship construction and giving details not only of the vessels themselves but of the changing techniques of the shipbuilding industry. These cover similar vessels to those noted in the first paragraph and include photographs of a circular yacht built for the Czar of Russia.

Also in the collection are over 200 reels of cinematograph film dating back to the 1920's and covering construction, launches, trials. The archives include financial and production records dating from 1847. These become progressively more complete from the 1880's onwards.

ANNEX

The collection of records derives from the following companies:-

John Brown Shipbuilding & Engineering Co. Ltd., (shipbuilding activities only) (1899-1968) and their predecessors James & George Thomson, marine engineers, Govan and Clydebank (1847-1897) and the Clydebank Shipbuilding & Engineering Company (1897 - 1899).

Fairfields' Shipbuilding and Engineering Company Limited, (shipbuilding activities only) (1890 - 1965) successors to John Elder & Co. (1864 - 1890) and predecessors of Fairfields (Glasgow) Ltd. (1965 - 1968).

Alexander Stephen & Sons Limited (1750-1968). Before the formation of U.C.S. the bulk of their historical records from 1895 had been deposited by the firm with the Department of Economic History, University of Glasgow.

Simons-Lobnitz & Co., dredger builders, Renfrew (1957 - 1964) result of amalgamation of William Simons & Company (1810 - 1957) and Lobnitz & Company (1848 - 1957). Records at present located date only from 1870. Older records were destroyed in 1964 on the closure of the yard and the passing of the goodwill to Alexander Stephen & Sons, Limited.

[Charles Connell & Co. records were retained by that firm and placed by them in Glasgow City Archives].

HON. SECRETARY'S NOTES

Subscriptions to the Council now stand at thirty-one individual and thirty-eight corporate members. The Council is now well represented in British Universities and libraries. The delay in sending out invoices for 1973/4 has been due to the retarded publication of this Newsletter, which they were intended to accompany.

The University of Glasgow Extra-Mural Department is promoting a course on 'The Practical Study of Scottish Industrial History' which will include the study of the documentation of industry.

The Council is cooperating with the Scottish Record Office in the publication of a survey of the records of Clyde Shipbuilding.

It is noted that the Glasgow City Archives Office, in which a large part of the recently deposited industrial records of the Clyde area are now located, has moved to a new and improved public searchroom at 30 John Street. This is in the City Chambers and the office is in the basement at that address.

A steady stream of requests for information from and concerning business records reported by the Council still continues to be received and, with the clearance of the U.C.S. records at the end of the year, this will increase substantially.
