EDITORIAL

Regular readers will require no notice of the fact that this edition of the Newsletter has over-run its expected publication date by some six months. As on previous occasions pressure of work on voluntary officers of the Council has defeated the intention to publish this journal at regular intervals. Members have been tolerant of this situation in the past and we hope that such forbearance will be continued. In spite of the delay in the appearance of this issue of the Newsletter, we hope that Newsletter 12 will appear at the end of the year to meet our policy of issuing two numbers of the Newsletter each year.

During the last twelve months the organisation, scope and administration of archives services in Scotland has undergone a significant change with regional re-organisation. The implications are far reaching and will be reviewed in a special article in the next issue of the Newsletter. Among the changes affecting officers of the Council is the appointment of Mr. Richard F. Dell, formerly Glasgow City Archivist, as Principal Archivist to the Strathclyde Regional Council. This will extend the already active contacts between the B.A.C. (Scotland) and interested bodies throughout the region. The work of the Council has also been strengthened with the appointment of Mr. Michael Moss, formerly Registrar of the Western Survey, as Archivist to the University of Glasgow. Mr. Moss has also agreed to represent B.A.C. (Scotland) at meetings of the Business Archives Council in London.

One of the main objectives of the Council has been to extend the interest in business records to all parts of Scotland, and in greater depth in the business community. The Newsletter is the principal way in which the Council has attempted to publicise its activities; yet for some time, many members have expressed a wish to experiment with other means of bringing the Council's work to the attention of a wider audience. As a step in this direction the Council decided at the last Annual General Meeting, to meet at six monthly intervals instead of once each year. The spring meeting, it was felt, could be held outside Glasgow in an effort to attract interested men from the business community who could not normally travel to meetings in Glasgow. The first such meeting was held in Edinburgh in May this year. More than twenty representatives attended. The meeting was held over lunch and incorporated an excellent talk on business records by Dr. Wray Vamplew of the University of Edinburgh, followed by a buffet luncheon. The meeting was a considerable success and it is hoped that it will be followed by others. Members who think their local area might

respond to such an occasion should not hesitate to raise the matter with the Editor or the Honorary Secretary.

In the meantime the work of preserving and listing business records in Scotland grows apace. The regional surveys continue to deliver an astonishing range of new records, some of which are noted in this issue. The growing scale of this work reflects the extending interest in business records as valuable sources for economic and social history. In forthcoming issues of the Newsletter we will attempt to include short articles to indicate to our members the ways in which business records throw light on problems of the past and present. Contributions from readers will, as always, be welcomed, since in this way we would hope to keep up with the varied interests of our members.

HON. SECRETARY'S NOTES

The membership of the Council has remained steady at thirty four ordinary and forty institutional members. A large number are still in arrears with subscriptions however.

The Scottish Pottery Society, with considerable interest in the industrial sites of the past, was formed October 1972 in Glasgow and is prospering. An Edinburgh branch has now been formed. Its Secretary is Miss Janet W. Osborne, 162 West Princes Street, Glasgow, G4 9DA.

The opening to public inspection of the Fairfields section of the U.C.S. records, now in Glasgow City Archives, was authorised by the Keeper of the Records of Scotland in April 1974. Considerable interest has been shown by both marine operators and marine historians. Not least among the latter are the well organised and highly documented Clyde River Steamer Club of which the Hon. Secretary is Mr. G.E. Langmuir, (Messrs. Dallas McMillan & Sinclair), 45 Renfield Street, Glasgow.

The following communication has been received from Miss Anna Dunlop, Editor of the Accountant's Magazine (Journal of the Institute of Chartered Accountants of Scotland) and a member of our Council:-

'MS Loaned to Antiquarian Collection

Another manuscript of considerable historical interest has been lent to the Institute's Antiquarian Collection by Messrs. Scott-Moncrieff, Thomson & Shiells, through its senior partner, Mr. G.C. Patterson, C.A., a Past-President of the Institute. This is the record of business concerned with the Newlands Trust. The fortune of John Newland was based on his considerable property in Jamaica and on the slaves who worked it. He left legacies of £50 to £100 to his nephews, nieces and other relatives in "North Britain", but all the rest of his estate was left to trustees who were enjoined to use the money for charitable purposes, in particular in the erection of a free school, in Bathgate, his home town.

The MS contains an inventory in an entry (dated 1800) of the slaves of the estate, nearly all identified by a single name, for example, Johnny (£200), Peter (£65), Nelly (£140). Some of the names were more imaginative, such as Othello and Venus. Some of the slaves' occupations are listed:- driver, cartman, watchman, cattle man, bricklayer, carpenter, boatman, housewoman, but the largest number were field workers. Slaves' children are also listed with prices from £30 to £80. There is, of course, in

in keeping with the period, no trace of revulsion against the practice of slavery: one is left with the feeling that, at least when the slaves were so valuable in terms of currency, they must have been comparatively well treated, even if for mercenary reasons only.

A dispute arose about executors of the Newlands Trust, and eventually it reached the highest level, i.e., the King in Council, in 1815. In fact, the King himself was, of course, unable to be present, but the cast at the hearing at Carlton House was extremely distinguished, being headed by His Royal Highness the Prince Regent and including the Archbishop of Canterbury, the Lord Privy Seal, Mr. Chancellor of the Exchequer, et al.

Accounting in Scotland: A Historical Bibliography: A Review.

The relationship between the profession of accountancy and business history in Scotland is an interesting one, since it suggests the question of how far economic development, for example in the eighteenth century, can be attributed to the growth of an accurate knowledge of accounting, or whether this is itself merely a side-effect of the increase in commercial activity. When we find, for instance, that the Corporation of Glasgow in 1695 appointed Robert Whytingdale 'for teaching the airt of navigation, bookkeeping, arithmetick and wryteing', this interest in commercial education would appear to be at least a pointer to the remarkable development of the city in the following century.

The present bibliography, the first to be produced in its field, is divided into three sections: the first listing books published in Scotland on accountancy, book-keeping and commercial arithmetic from 1683 to 1920; the second listing published transcripts of accounts before the early nineteenth century, and books and articles discussing these; and the third dealing with works on the history of accountancy in Scotland. The compiler is a qualified librarian, and the annotations are by the Professor of Accountancy at Dundee University, who has also contributed an appendix on the earliest item in the list, Robert Colinson's Idea Rationaria, published in Edinburgh in 1683. The entries are in the standard bibliographical form, and include locations of copies for each work listed under twelve libraries, nine of which are in Scotland.

The first and longest section is perhaps the most useful, and should provide the means for solving the many problems faced by business historians in dealing with early accounts, since the works listed presumably give the theoretical foundation for the accounting practices employed. In addition to this, many of the textbooks amount to manuals of general business practice, and some deal with more specialised forms of accounts, such as those used by farmers and customs officials. It is more surprising to find that the teaching of accounts maintained its early links with the art of calligraphy throughout the eighteenth century. It was in 1798, for example, that a Greenock schoolmaster, Colin Buchanan, published The Writingmaster and Accountant's Assistant, although this title must by then have seemed slightly old-fashioned.

The second section lists accounts in print, mainly consisting of burgh, estate or household accounts, and government publications such as the Exchequer Rolls. The majority of these are necessarily much older than the works listed in the first section, and are not in double-entry form, but are examples of the older 'charge' and 'discharge' account. In consequence of this, their relevance to the first section is perhaps doubtful, and the majority of them are more likely to interest the local historian than the historian of accountancy. To this section may be added George Gray (ed.), Account of the Common Good of the Royal Burgh of Rutherglen, 1654-1655 (Glasgow, 1911).

Books and articles on the history of Scottish accounting form the third section, which includes material on individual firms and biographical notes on prominent accountants, drawn from the Accountants Magazine. Indices of authors and titles, and several illustrations, including reproductions of specimen pages of accounts from several of the works listed, are also provided. This bibliography is the first production of the Scottish Committee on Accounting History, and should provide the essential foundations for further work in this field.
